Luciano Floridi

Updates:

Luciano Floridi was appointed Chairman of the expert group, organised by the DG INFSO of the European Commission, on the impact of information and communication technologies on the digital transformations occurring in the European society. The project is part of “Digital Futures”, a EU visioning initiative that seeks “to anticipate possible issues and generate inspiring ideas for the future of policy-making in the digital realm”. It will deliver its report by the end of 2012.

Luciano Floridi was elected member of the advisory board of the InfoMetrics Institute <http://www.american.edu/cas/economics/info-metrics/> The Institute – within the College of Arts and Sciences of American University – was launched in August, 2009. The Institute’s mission is to promote the interdisciplinary study of information, information processing and decision rules based on efficient use of information. That mission is achieved through collaborations among researchers across the scientific spectrum and dissemina-

tion of knowledge through conferences, workshops and seminars as well as through short-term, hands-on classes at the graduate and post-graduate level.

Luciano Floridi delivered the Prestige Lecture on Science of Information (Purdue University, 31 October, 2011). The lecture series is organised by the NSF-funded Center for Science of Information <http://soihub.org/>

Luciano Floridi was a keynote speaker at the Symposium on Digital Ethics (October 28) that will inaugurate the new Center for Digital Ethics and Policy (digitaletics.org) at Loyola University in Chicago. The Center for Digital Ethics and Policy, hosted by the School of Communication at Loyola University Chicago, seeks to foster more dialogue, research, and guidelines regarding ethical behavior in online and digital environments.

Luciano Floridi was awarded a grant by the Arts and Humanities Research Council, to work on information quality standards, in collaboration with Google UK.

ELIZABETH BUCHANAN

Elizabeth Buchanan was awarded a University of Wisconsin Stout Research Award to study how community-based participatory research models can be used in online environments.

Elizabeth Buchanan was appointed to the editorial board of the journal Philosophy and Technology, whose Editor-in-Chief is Luciano Floridi. She was also appointed associate editor for the Journal of Empirical Research on Human Research Ethics.

INSEIT members Elizabeth Buchanan, Scott Dexter, and Keith Miller, along with Ken Fleischmann, University of Maryland, were recently awarded a \$400,000 collaborative National Science Foundation grant to evaluate ethics pedagogy in computer and information technology graduate coursework. Their project is a multi-institutional study of their four universities, and involves content analysis, survey data collection, and focus group work. They will then work with AMC and IEEE on alignment of university level coursework with the ethics and professionalism standards for those associations.

CfP: Well-Being in Contemporary Society

International Conference on the Philosophy and Science of Well-being and their Practical Importance

University of Twente, Enschede, Netherlands

July 26-27, 2012

About the Conference

In recent years, well-being has enjoyed a renaissance in philosophical discussions, as well as in fields like psychology, economics, development studies and sociology. Although these approaches share a common goal – to better understand what well-being is and how it can be enhanced – these developments have led to a great diversity in philosophical and scientific approaches to the analysis of well-being. Despite the increasing amount of research, most of the work on well-being is also performed at a highly abstract level. This is especially true in philosophy, but relatively little work has been devoted to the application of theories of well-being also in other fields, in particular when it comes to an understanding of life in contemporary society. Developments such as globalization, consumerism, and the rapid innovation and use of new and emerging technologies, all exert significant impact on the well-being of people living today, and we need a better understanding of their consequences for well-being.

Contemporary society requires that well-being researchers examine these problems – and, if possible, propose solutions to address them. This international conference aims to bring together researchers from various disciplines, including, but not limited to, psychology, economics, sociology, philosophy and development studies, in order to examine the practical role of well-being in contemporary society.

Potential Topics

We are looking for contributions that examine the notion of well-being in the context of contemporary society. The conference particularly welcomes papers that employ a notion of well-being to address social, political and ethical issues in present-day society. Suggested topics for the workshop include, but are not limited to:

- Theoretical developments and approaches in the philosophy and science of well-being in relation to contemporary society, culture and life.
- Well-being in social and political philosophy and/or in policy studies
- Positive psychology (and related research fields) and its practical applicability
- New and emerging technologies and well-being
- Intercultural and interpersonal comparisons of well-being
- Reliability, validity and applicability of well-being measures
- Other specific practical issues pertaining to well-being in contemporary society

The workshop will include both invited papers and an open call for papers. For the open call, we invite extended abstracts (1500-2000 words). Please anonymise the abstract, and include title, name and address in the accompanying email. The abstract, and any questions you may have about the conference, should be sent to wics2012@utwente.nl. Your abstract should be submitted before February 15th 2012, and will be subject to blind peer review.

Publication

Following the conference we aim to publish the papers, subject to a blind review process, in either an edited volume or a special issue of a relevant journal. We did so successfully with our previous conference, *Good Life In a Technological Age*, from which select papers were published as book in the prestigious *Routledge Studies in Science, Technology and Society* series, which will be available in February 2012.

Ethics of Secrecy

Edited by Daniel Nagel, Matthias Rath, and Michael Zimmer

The concept of “secrecy” is bound up in a variety of aspects of information ethics, sometimes in conflicting ways: respecting personal privacy and opposing undue surveillance ensures a certain level of secrecy in one’s personal life and activities; to ensure security and public safety, government secrecy is often justifiable; open records laws and whistleblower protections are meant to limit government secrecy and promote transparency; corporate trade secrets remain secret to protect investments and economic growth; the secrecy of our personal lives is increasingly shattered – and commodified – through social media or, to paint a black picture: the personal freedom to conceal and reveal information and thus even the concept of personal identity might be at stake.

This special issue will explore the complex nature of “secrecy” in our contemporary information society. The ethical exploration of secrecy must be renewed in the face of the multiple and shifting social, political and cultural contexts in which information and people flow.

We welcome papers discussing the ethical complications of “secrecy”, including, but not limited to, these areas of inquiry:

- Privacy, reputation, and the secrecy of personal information
- Tensions between secrecy and transparency
- Corporate secrecy and the ethics of whistleblowing
- The value of secrecy in a social information ecosystem
- The ethics of secrecy across cultures and societies
- Secrecy, transparency, privacy: moral principles of democracy?
- Government secrecy and the ethics of WikiLeaks
- Privacy and secrecy in ethical and sociological discussion
- The “interplay” between secrecy and mass/social media
- Privacy and secrecy in the discussion of communication science

Submission guidelines:

Potential authors are requested to submit an extended abstract (for details see http://www.i-r-i-e.net/about_irie.htm) by December 31, 2011. Abstracts may be submitted in the native language of the author though an English translation of this abstract must be included if the chosen language is not English. IRIE will publish articles in English, French, German, Portuguese or Spanish. The author(s) of contributions in French, Portuguese, or Spanish must nominate at least two potential peer reviewers.

Abstracts will be evaluated by the guest editors.

Deadline for the final article (usually ca. 3,000 words or 20,000 characters including blanks) is May 1, 2012. All final articles must conform to the IRIE style sheet. All full submissions will be subject to peer review. Therefore the acceptance of an extended abstract does not imply the publication of the final text, unless the article has passed the peer review and revisions (if required) have been included in the text.
